• •to substantially and procedurally indemnify the NGO Nexus Emilia-Romagna ETS, with registered office in Via Guglielmo Marconi, 69 (40122) Bologna, and to keep it harmless from any loss, damage, liability, cost or expense, including reasonable legal fees, deriving from, or in any way connected to, claims or disputes by third parties, relating to the transfer of intellectual property rights on the Work in favor of the NGO Nexus Emilia-Romagna ETS. ALL OF THE ABOVE STATED, DECLARED AND GUARANTEED THE AUTHOR EXPRESSLY GIVES UP TO THE NGO NEXUS EMILIA-ROMAGNA ETS:

- •all intellectual property rights, none excepted or excluded, in relation to the Work created on the occasion of the photography competition with free participation, aimed at professional or non-professional photographers of Somali nationality and/or any other nationality, with the theme " Tell us about dignified and inclusive work or its opposite."

The Data Controller guarantees you the exercise of the right of access and, in the cases provided for, the right to rectification, cancellation and data portability. You also have the right to request the limitation of the processing of the data provided and to object to the processing.
