The competition is open to all adults, professionals and non-professionals, of any nationality.

The theme

What does decent and inclusive work (or its opposite) mean to you? Tell us about it with photographs and short texts. From scenes of urban life, to portraits, telling a story of challenges overcome or opportunities created in the workplace. The national and international aspects of the competition are intended to capture a unique insight into working conditions and the ways in which employment rights are intertwined with the social and professional aspects of everyday life. Also through your visual exploration we aim to raise awareness and celebrate the universal value of decent and inclusive work both in the world and, in particular, in Somalia.

Who we are

Nexus Emilia Romagna ETS and FESTU (Federation of Somali Trade Unions) focus their efforts on the promotion of decent work, gender rights and the campaign against child labour, implementing the project "I.N.FORMA.L AID 012590/03/0" in Somalia.

The project is financed by the Italian Agency for Development Cooperation (AICS), and realized by Nexus Emilia Romagna ETS and FESTU, in collaboration with the Ministry of Labor and Social Affairs of Somalia (MoLSA), the Somali Chamber of Commerce and Industry (SCCI), the Organization African Regional of the International Trade Union Confederation (ITUC-CSI Africa) and the Italian General Confederation of Labor (CGIL) as technical partner.

The project aims to promote the sustainable transition from an informal to formal economy in three sectors: fishing, textiles and small trade, through inclusive development actions to promote decent working conditions, strengthen the rule of law, peace, social dialogue and human rights.

How to participate

There are **2 sections**:

an international one and a national Somali one.

Those who present photographs taken in Somalia can participate in both sections.

• Competitors can send up to a maximum of 4 photographs per section.

• For each photograph, it is optional and preferable to send a text of a maximum of 650 characters (including spaces) that accompanies the images, also explaining how the proposals align with the theme of the competition.

• The title, location, year of the shoot and which section to participate in must be indicated.

• Format of photographs in jpg from 1500 to 2000 pixels on the long side, maximum size 2MB

• The file name must be composed as follows: image title + progressive number_by author's nickname.jpg (e.g. work2_byJX.jpg).

• The duly completed participation form must also be attached.

Prizes

The photographs sent and selected will be used to create **promotional and/or communication and visibility mate-rial** for the Project, including a calendar.

6 photographs per section will be awarded, with photographic and/or computer equipment.

The **awards ceremony** for both sections will be held in Mogadishu (Somalia) in December 2024 with the possibili-

ty of participating also via video conference.

Anyone who cannot be physically present will receive the prize via courier.
