Training and professional development to facilitate the transition of informal workers in the fishing, textile and retail/small trade sectors toward the formal economy

The first six months of 2024 have been crucial in defining and launching professional training programs for fishery, textile and retail/small trade informal workers. This essential training will facilitate the sustainable transition process of informal enterprises to the formal economy.

In these professional training and upskilling programs, 20 beneficiaries (including sector trainers and facilitators) were initially involved and trained, along with more than 130 young beneficiaries (at least 50% of whom were women).

While sector trainers and facilitators participated in a professional development course focused on assisting and supporting the formalization of micro and small informal enterprises, the training beneficiaries were divided into the three target sectors and received detailed sector-specific training.

The professional development course for sector trainers, involved through the collaboration with project counterparts such as the Somali Chamber of Commerce and the Ministry of Social Affairs, provided skills and knowledge on: participatory and inclusive learning methodologies; the local labor market; employment opportunities in the three target sectors; tools for managing formal enterprises and best practices for creating decent, inclusive, and socially protected work; workplace health and safety; women's empowerment and the reduction of gender discrimination.

The sector training for young beneficiaries focused more, both practically and theoretically, on the formalization programs for micro and small enterprises, sector opportunities, health and safety (general and sector-specific risks, occupational diseases, prevention measures, protection and the use of equipment), social protection practices/supplementary welfare systems and labor inclusion.

At the end of the sector training, 65 young beneficiaries have been selected based on different criteria (acquired skills, personal motivation, etc.) to be the protagonists of the pilot action that will lead in 2025 to test the sector programs that will facilitate their transition to the formal economy in the fishery, textile and retail/small trade sectors.

In June 2024, the first training sessions were realized, but due to internal security reasons in the country, the second part of the training will take place in 2025.

This program will equip them with technical skills, a start-up toolkit and transversal competences that will provide them with greater and new income-generating opportunities, increased awareness of their rights and active participation in the socio-economic development of the country, in addition to reducing the gap between the skills required and offered.

Staff project meetings and initiatives in Italy

As scheduled every six months, a staff project meeting has been organized.

In July 2024, we chose the national headquarters of CGIL as the venue. In Rome, we had the opportunity to monitor the actions carried out, share the future project plans, add knowledge about the Somali context and discuss possible actions to address the issues that the challenging Somali context entails.

The July meeting was also an opportunity to provide a public feedback on the activities carried out.

Omar Faruk Osman Nur, General Secretary of FESTU, was invited to participate as a speaker in the event 'Democracy and the Role of Trade Unions in Defending Work and the Rule of Law,' held in Bologna on July 5 at the Lumière Cinema.

The meeting, coordinated by Nadia Vorcelli, a journalist from the DIRE agency, featured a debate on multiple fronts regarding democracy and the rule of law, involving some protagonists from ongoing struggles taking place in various countries such as Turkey, South Korea, Italy, and, of course, Somalia.

Omar Faruk Osman also explained to the audience what the strongest link between democracy and the rule of law is for their country, namely the possibility of inclusive growth, peace, and social dialogue. In practice, the pillars of the ongoing project.

"Decent and Inclusive Work" Photo Competition

On September 30, 2024, participation in the **Decent and Inclusive Work photography competition** ended, an initiative promoted as part of the I.N.FORMA.L. AID 012590/03/0 project by Nexus Emilia Romagna ETS and its partners.

The competition, open to national and international participants, aimed to raise awareness and stimulate collective reflection on the concept of decent and inclusive work and its opposite, highlighting its many facets through photographs and texts. **What does decent and inclusive work mean?** This question was at the core of the initiative, which invited photographers to tell, through images, the challenges overcome, the opportunities created, and the stories behind every job. The photographs explored scenes of urban life, portraits, and stories of workers, intertwining labor rights, social aspects and professional dynamics with the aim of capturing a unique perspective on working conditions, emphasizing the universal value of decent and inclusive work that unites us all.

In less than a month, the competition received a wide participation: photographers, both amateur and professional, have submitted over 90 photographs, enriched with their reflections.





Another important milestone of the I.N.FORMA.L. project in 2024 was the realization of the '**Survey on the Informal Economy in Somalia: In Search of Sustainable Change**' curated by Abdirisak Warsame, in collaboration with FESTU and CGIL that will be published in three versions: Italian, English, and Somali in the early months of 2025.

The research is a fundamental part of the strategy to transition the Somali economy from informality to formality by identifying and addressing the challenges faced by informal businesses, with the involvement of three key components: the government, workers, and employers. Through an overview of the Somali economy, the survey examined crucial sectors such as fishery, textiles, and small informal businesses to gather new insights and promote a deeper understanding of the country's informal economy.

This process has been crucial in highlighting the benefits of socially protected labor, defending workers' rights, and addressing the vulnerabilities of informal work.

The survey was also essential for developing a proposal for a National Action Plan, formulated by a Tripartite Committee made up of the most important Somali stakeholders: the Somali Ministry of Labor and Social Affairs (MOLSA), the Somali Chamber of Commerce and Industry (SCCI) and the Federation of Somali Trade Unions (FESTU).

The proposal will be detailed and aligned with national aspirations aimed at achieving a solid formal economy that can support inclusive growth, improve working conditions and adhere to the principles of social justice.
